Complete stories about these wonderful projects begin on page 26. What is not included in any of the articles is the work involved in selecting the winners. It begins with the solicitation of entries, continues with the preparation of entries by engineering firms, and concludes with a grueling judging process.

Of course, saying the work concludes with the judging is a misnomer. Once the 1998 competition is over, we start working on the 1999 event. To be eligible, a significant part of the framing system must be steel wide-flange structural shapes or hollow structural sections and building construction

must have been completed between January 1, 1995 and December 31, 1998. Projects may be located in the U.S., Canada or if The Beam Mexico, and both new buildings and renovation (major retrofit, expansion or rehabilitation) projects are eligi-

> Buildings can be submitted in one of three categories: projects up to US\$10 million in constructed value; projects greater than US\$10 million but less than US\$25 million; and projects over US\$25 million.
